Mission Statement



Registrar's Message

2022 was a significant year for the College marking an important shift in all College operations with a focus on education of Council and Committee Members. The College instituted a much more rigorous education program with annual business meetings for our Discipline Committee and Inquiries, Complaints and Reports Committee as well as business meetings for our Quality Assurance Committee and Registration Committee. We also provided training to our Committee Chairs to reinforce the importance of addressing conflicts of interest and to maximize the decision-making process and outcomes of any committee to best meet its mandate. A competency profile



and self-assessment was created for any registrant considering election to Council and Council orientation with a view to tailoring the training of new Council members and ensuring proper support is available for optimal functioning of Council.

In February 2022 Council voted to approve a new Strategic Plan, the first of its kind for the College, that will guide the College through the next 3 to 5 years. The Strategic Plan emphasized two important commitments of Council: to ensure the College is sustainable and to support the adoption of the Podiatry Model in the province. Council's view of the appropriate Podiatry Model includes the following:

- All registrants use title of "podiatrist";
- College name change to "College of Podiatrists of Ontario";
- Removal of legislative cap on registering podiatrists allowing for registration of DPMs; and
- Podiatry program(s) is created to train podiatrists to full scope of podiatry practice with education pathways for any registrant wishing to upgrade skills. The College supports a full scope podiatry model mirroring the anatomic and treatment scope of practice available to podiatrists in BC and Alberta.

Sustainability, as the other key initiative cited in the Strategic Plan, means ensuring the College has proper resources to fulfill its mandate of protecting the public. Sustainability has been





optimized in a number of ways including: an annual cost of living increase to annual dues to protect against the need for large increases; a reserve fund to ensure the College is financially able to manage unexpected costs; cost neutrality for the College's

Registration Examination; smaller Committee sizes; increased number of

practice assessments; Quality Assurance Committee's use of

panels for decision-making; and annual Continuing education requirements to align with best practices in professional health regulation. The College has continued to enforce its Zero Tolerance Policy in respect of Unethical Business Practices. Doing so has helped to instill stakeholder confidence in the College fulfilling its mandate of public protection.

To ensure that the College and Council also embraced the spirit of Equity, Diversity, Inclusivity (EDI) and Truth and Reconciliation, College staff and Council members engaged in continuing education towards the College's commitment to Truth and Reconciliation by completing the online modules of the 4 Season's of Reconciliation. Further, Council adopted a Land Acknowledgement that is read before the commencement of every Council meeting. Recognizing that EDI and Truth and Reconciliation have particular importance within healthcare and within professional health regulation, the College staff and Council remain committed to embedding these concepts throughout the College's operations. The College and Council remain committed and will create further avenues for EDI and Truth and Reconciliation within the College's work going forward. This commitment is matched by the new continuing education (CE) requirements set by the Quality Assurance Committee requiring members to engage in EDI as part of their CE.

In addition, I have worked to increase the College's profile by various means including speaking at events such as the OSC's annual conference and the OPMA's annual general meeting. I have presented as well to stakeholders with a view to messaging the College's Strategic Plan and Operations to meet its mandate to protect the public. The College held its inaugural Townhall meeting in December 2022 whereby registrants were invited to attend in person or virtually with me and staff hosting the event. I provided a presentation and enjoyed interacting with attendees as well as answering questions raised by attendees. Future Townhalls will become a staple. I have committed the College to engage with other regulators and to participate fully in the Health Profession Regulators of Ontario to assist the College in aligning with best practices in health regulation. I look forward to continuing these efforts in 2023.

Finally, the College undertook the first of its kind Registrant Survey to better understand the important work our registrants are engaged in. The College will continue to survey registrants to ensure we stay abreast of trends in clinical practice to better inform our Quality Assurance Programs and Practice Assessments as well as our continuing educational requirements. We are pleased to continue practice assessments that have doubled in number over past years and we are very pleased to note that registrants are demonstrating excellence in their practices.

As always, I remain committed to moving the College forward, aligning the College with best practices in professional health regulation and assisting Council in realizing on its Strategic Plan.

Ver the past year we have realized many significant achievements. Chief among these is a much more streamlined functioning of the many committees of the College, and even with Council itself.

These improvements have occurred in a measured fashion by way of a purposeful move toward smaller, more nimble-sized committees along with committee members better prepared to serve those committees. A structured mechanism is now in place whereby these committees' function under the oversight of Chairs that have received education

While we welcomed several new members to Council in 2022, these professional members were experienced in that they had served the College through various committees in years gone by. This experience, coupled with a rigorous new councillor orientation session which clearly outlines the obligations and expectations of self-regulation in the public interest, helps to ensure that they will be a welcome asset to this governing body. I do not think it an overstatement to say that I believe we are now doing our job as a regulator better than ever before. Something we can all be proud of, but kudos most especially to the Registrar and her staff for providing the direction that moved us forward on so many fronts consistent with the best practices of other health regulators. I also know that they will not rest on the laurels of these achievements, but

2022 Highlights

he College achieved some important work in 2022 – staff, Council and committee members all played an intrinsic role in serving and protecting the public. In addition to the day-to-day work, there were several key highlights worth noting.

In February 2022, Council approved the College's inaugural Strategic Plan. The Strategic Plan includes a commitment to modernize and innovate footcare health in Ontario, by adopting the podiatry model and removing the cap on podiatrists (discussed in more details below). The Strategic Planning Committee also worked on developing key performance indicators (KPIs) to measure the College's success in meeting the objectives in the Strategic Plan, which were adopted by Council in early 2023.

Council also supported an increase to the registration examinations fee. While Council was sensitive to the concerns of some Michener students, it considered that there had not been a fee increase since 2015 and the increase was needed to ensure the College was moving in the direction of cost neutrality with respect to administering the entrance exams. Since 2014, the College has undertaken a significant amount of work, under the guidance of Martek Assessments, to improve the registration examinations so that the College continues to meet its public protection mandate. The registration examinations are one of the College's most significant expenses, and the cost of developing and administering the examinations has substantially exceeded the amount covered by the fees charged. The examination fees were not increased with a view to making a profit, but rather the College's goal was to break even.

At the end of 2022, the College retained a regulatory consultant to evaluate College Council's effectiveness. The evaluation was completed in January 2023, and going forward, similar evaluations will be conducted every three years. The consultant evaluated Council in a number of

areas, including Council member competency, Council meeting materials and Council Chair effectiveness. The results of the evaluation are available on the College's website.

Finally, in December 2022, the College held its inaugural town hall, which was an opportunity for members to meet the Registrar and ask questions about the College's strategic direction and priorities, and to for the College to engage the membership about issues/concerns facing the profession.

EQUITY, DIVERSITY, AND INCLUSION

In 2022, the College made a commitment to incorporate and prioritize equity, diversity and inclusion (EDI) in its work. For starters, the College adopted a Statement on Equity, Diversity, and Inclusion, which recognizes the College's commitment to promoting EDI within Council, staff, and consultants. The College also incorporated a land acknowledgment into the start of each Council meeting. College staff, Council and committee members completed the First Nations University's 4 Seasons of Reconciliations course, and in October 2022, Council voted to include mandatory EDI courses as part of the College's Continuing Medical Education requirements for 2023.

The College's Strategic Plan includes a commitment to modernize and innovate footcare health in Ontario, with the goal that members will practice their full scope of demonstrated competencies as determined by the College. The Plan outlines how the podiatry model will enhance patient access to a range of proven and effective footcare services, to reduce pressure on the healthcare system and potentially avoid lower limb amputations. Specifically, the Plan supports access to care for equity seeking groups, such as indigenous communities and rural populations. Recent Ontario-based data demonstrates that rates of lower limb amputations are significantly higher among Ontarians living in remote Northern and rural communities as well as those in First Nations and Indigenous communities. The data demonstrates that Ontarians with access to treatment by College members are less likely to experience serious, adverse outcomes.

The College is actively supporting the work of Health Profession Regulators of Ontario (HPRO)

as it develops supports for colleges to advance their work in Diversity, Equity and Inclusion within the full range of their regulatory practices. Specifically, the September 2021 report commissioned by HPRO from Dr. Javeed Sukhera recommended that regulators should critically appraise existing policies,

particularly those for registration, complaints/discipline, and

policy/governance. The HPRO Anti-Racism in Health Regulation project provides valuable information for the College to use in conducting these reviews within the context of an Equity Impact Assessment. Current HPRO project activities are designed to provide a set of guiding indicators and support tools the College will use to enable a customized assessment of equity impact, reflecting its particular needs.

PRACTICE ADVISORY SERVICE

In June 2022, Peter Stavropoulos, Podiatrist, assumed the role of Acting Practice Advisor (PA). The statistics in this report reflect the data gathered from January to December 2022.


Purpose

The PA provides professional practice advice on behalf of the College, supporting members by making sound and ethical clinical decisions that comply with legislative requirements, the Standards of Practice, and College policies and guidelines. The PA is also available to support the public by providing information to them about the service our members can provide to them and where they can obtain the care they require.

The Public Interest

In addition to aiding our registrants, the PA service responds to inquiries from multiple stakeholders including other healthcare professionals, third party insurance carriers, clinic managers/owners/ employers, regulated health Colleges, as well as the public. The PA is also available to support the public with questions about the practice of chiropodists and podiatrists in Ontario.

Data Breakdown from January 1 - December 31, 2022, and Sources of Inquiries In 2022, the Practice Advisor received 491 phone calls and emails.



UPDATES TO STANDARDS, GUIDELINES AND ADVISORIES

In 2022, Council approved the Guideline for Suspension to provide guidance to members who are administratively suspended or suspended by a College committee. The Standards and Guidelines Committee also developed a Fee Guideline to assist members in understanding their legal and professional responsibilities in relation to fees, billings, and accounts, which was approved by Council.

College of Chiropodists of Ontario

In late 2022, the Standards and Guidelines Committee prepared a guideline for members to determine their currency of practice. The guideline clarified what is considered to satisfy the clinical practice requirement of "3 months in 2 years". The guideline was approved by Council at its January 27, 2023 meeting.

AMENDMENTS TO THE COLLEGE'S DRUG REGULATION

The Injections, Prescriptions and Standard of Practice (and its schedules) section of the General Regulation, made under the Chiropody Act, 1991, outlines the drugs and substances authorized to chiropodists and podiatrists.

In 2022, the College continued to work with the Ministry of Health to move the amended regulation through the approval process. The College anticipated that the amended regulation would come into force and effect January 1, 2023, but unfortunately this was delayed because of a provincial election, and a change to the American Hospital Formulary Services, which was the basis for the category approach the College proposed. The MOH advised that, because the AHFS was sold and it is now a for-profit entity, it was cost prohibitive to rely on that approach. As a compromise, the MOH agreed to adopt an updated list. In the College's view, the revised drug list is an interim measure, which will help protect the public by giving members the ability to prescribe drugs they are currently unable to prescribe. The College will continue pushing for a category approach to the regulation.

COLLEGE PERFORMANCE MEASUREMENT FRAMEWORK

In 2020, the Ministry of Health (MOH) established a new annual reporting requirement for all regulatory health colleges. The College Performance Measurement Framework (CPMF) enables the College to measure and report, in a standardized way, how it is acting in the public interest. Completing the CPMF is an opportunity for the College to reflect on its achievements, work towards achieving best practices in regulation and to identify areas for continuous improvement.

The Ministry requires the College to report on the following seven broad domains: Governance, Resources, System Partners, Information Management, Regulatory Policies, Suitability to Practice, and Measurement, Reporting and Improvement.

The College submitted its third report to the MOH in March 2023, which reported on its performance in 2022. Once again, the College made several notable improvements from the previous year's report. For example, the College implemented a self-reflection matrix that candidates must complete prior to standing for election. The College also retained a third party to assess and evaluate the effectiveness of Council. The evaluation was completed

.

at the January 2023 Council meeting and the results of the assessment are available on the College's website.

The College fulfilled other obligations in the CPMF, including implementing a survey to evaluate the effectiveness of the complaints process, developing key performance indicators to track the goals and objectives in the Strategic Plan and implementing a policy outlining the criteria for disclosing and information sharing. The College also committed to making further improvements in the 2023 reporting cycle, including implementing EDI into its standards, guidelines and policies and reporting regularly to Council on its KPIs.

QUALITY ASSURANCE

In 2022, the College made several key improvements to the Quality Assurance program. Most importantly, the College conducted 37 on-site assessments (representing approximately 5% of the membership), which was a substantial increase from the assessment conducted in 2021. Also, the Quality Assurance Committee revised the CE policy to allow for more online/virtual credits and to provide a financial penalty for members who have not completed their CE credits when audited. In October 2022, Council voted to imbed equity, diversity, and inclusion (EDI) into the registrant continuing education requirement. Beginning in 2023, registrants must complete five hours of continuing education related to EDI. Registrants are provided with a list of resources but can also choose the EDI program that best suits their continuing education objectives, as identified in their self-assessment tool.



Executive Committee

n 2022, the Executive Committee met 11 times (virtually) and continued its oversight role of financial monitoring, strategic planning, governance and risk management practices and responsibilities for the College. The Executive Committee is a statutory committee that makes decisions between Council meetings. It has all the powers of Council with respect to any matter that, in the Committee's opinion, requires immediate attention, other than the powers to make, amend or revoke a regulation or by-law.

The Committee recommended to Council the approval of the proposed 2022 budget as well as the 2022 Audited Financial Statements.

Quality Assurance Committee

The Quality Assurance Program provides regulatory oversight through annual practice assessments and continuing education opportunities to ensure that chiropodists and podiatrists in Ontario are practicing in accordance with the College's standards.

SUMMARY OF THE 2022 ACCOMPLISHMENTS AND ACTIVITIES

PRACTICE ASSESSMENTS

In 2022, the College conducted 37 practice assessments, of which 54% were concluded with no further action taken by the Quality Assurance Committee. Sixteen percent of the assessments required the registrant to provide a written response confirming they had rectified minor deficiencies, while 27% required more detailed remediation and follow-up. One (1) matter was referred to the Inquiries, Complaints & Reports Committee.

2022 was the first year that the College conducted practice assessments of 5% of the registrants. Overall, the practice assessments showed that registrants are meeting the Standards of Practice and exhibiting a high level of skills, knowledge, and judgement.

CONTINUING EDUCATION

The College runs a two-year continuing education cycle, with a cycle ending on December 31, 2021. In 2022, the College conducted eighty-six (86) continuing education audits. Despite the pandemic, the majority of registrants were able to obtain the required fifty (50) credits. This was facilitated by the College removing the cap on the number of continuing education credits that could be obtained virtually.

In 2022, the Council approved a motion that now requires registrants to obtain a minimum of five (5) continuing education credits specifically focused on equity, diversity, and inclusivity training.

Inquiries, Complaints & Reports Committee

The Inquiries Complaints and Reports Committee ("ICRC") investigates complaints and reports to address concerns about the conduct and practice of Ontario chiropodists and podiatrists.

After a complaint or report is investigated, the ICRC decides what action to take. The ICRC may do any one or more of the following:

- refer allegations of the registrant's professional misconduct or incompetence to the Discipline Committee;
- refer the registrant to a panel of the ICRC for a health inquiry;
- require the registrant to attend before a panel of the ICRC to be cautioned;
- require the registrant to participate in a specified continuing education or remedial program (educational program); or
- take other action including providing advice to the registrant, accepting an undertaking, accepting a permanent resignation or taking no action.

If the ICRC is satisfied that a complaint is an abuse of process, it is required to take no action.

SUMMARY OF THE 2022 ACCOMPLISHMENTS AND ACTIVITIES

The ICRC reviews three types of cases:

COMPLAINTS:

The complaint process is a formal process set out in legislation. Complaints may be submitted by any member of the public.

REGISTRAR'S REPORT INVESTIGATIONS:

Registrar's Investigations commence because of concerns that are not submitted as a formal complaint. Reports come from employers, facility operators, registrants, and others. Based on the information, if the Registrar determines that there are reasonable and probable grounds to believe that a registrant has committed professional misconduct, or the registrant may be incompetent, an investigation is initiated.



The ICRC conducts inquiries into whether a registrant has a mental or physical condition or disorder that impacts the registrant's capacity to practise safely. The ICRC makes inquiries and may require the registrant to undergo medical examinations and suspend the registrant's certificate of registration if he or she does not attend or

comply. The ICRC, after reviewing the results of its inquiries, may refer the matter to the Fitness to Practise Committee.


SUMMARY OF ICRC DATA FOR 2022

The College received 20 complaints in 2022, conducted four Registrar's investigations, and received one referral from the Quality Assurance Committee, for a total of 25 cases in 2022. The Committee disposed of 27 files in 2022, which included matters carried over from the previous year. Three matters were referred to the Discipline Committee in 2022.

For the Registrar's investigations that were disposed of in 2022, the issues related to breaches of College standards, competence/patient care, sexual abuse/harassment and boundary violations, and practising while suspended by the Discipline Committee.


The ICRC did not conduct any health inquiries in 2022.

DISPOSITIONS: COMPLAINTS AND REGISTRAR'S REPORTS (2022)



APPEALS

Complainants and registrants have the right to appeal the decision of the ICRC within 30 days, unless the decision is to refer the matter to the Discipline of Fitness to Practise Committee.



Inquiries, Complaints & Reports Committee (continued)

The review process is handled by the Health Professions Appeal and Review Board (HPARB), which can review the adequacy of an investigation and/or the reasonableness of an ICRC decision. HPARB is composed of members of the public appointed by the Lieutenant Governor in Council on the Minister of Health and Long-Term Care's recommendation. More information about HPARB is available at www.hparb.on.ca.

In 2022, one decision was appealed to HPARB.

Discipline Committee

The Discipline Committee is a statutory committee under the *Regulated Health Professions Act, 1991*. The Discipline Committee holds hearings into allegations of a registrant's professional misconduct or incompetence, which has been referred to the Committee by the Inquiries, Complaints and Reports Committee. If a panel of the Discipline Committee finds a registrant has committed an act of professional misconduct it may make an order doing any one or more of the following:

- Directing the Registrar to revoke or suspend a registrant's certificate of registration or to impose terms, conditions and limitations on the registrant's certificate of registration;
- Requiring the registrant to appear before the Committee to be reprimanded;
- Requiring the registrant to pay a fine not exceeding \$35,000.00 to the Minister of Finance
- Requiring a registrant to pay all or a portion of the College's costs related to the matter brought before the discipline committee.

SUMMARY OF THE 2022 ACCOMPLISHMENTS AND ACTIVITIES

In 2022, the ICRC made three referrals to the Discipline Committee. There were eight Discipline Committee hearings in 2022 – six were uncontested and two were contested (one partially).

In 2022, approximately \$176,000 in costs were awarded to the College (and recovered), which accounts for roughly two-thirds of the cost the College incurred to prosecute the seven completed matters.



Registration Committee

The Registration Committee supports the College's public protection mandate by developing, establishing, and maintaining standards of qualification for persons to be issued certificates of registration with the College.

The Registration Committee met on four occasions in late 2022.

EXAMINATION COMMITTEE

The Examination Committee develops, maintains, and administers the College's qualifying examinations. In 2022, 40 applicants wrote the qualifying examinations; the examinations were held in early June and early November.

The composition of the Committee changed in 2022, by designating a core group of registrants (both Council and non-Council members) to oversee the entire examination process. While a subcommittee of item writers was formed whose primary objective is to create content for the examination question bank.

The Committee made the decision to split the multiple-choice examination into two separate examinations: with one examination focusing on Jurisprudence and the other examination focusing on Core Competencies. In 2023, the College will roll out the new Jurisprudence examination, consisting of 80 multiple-choice questions and a new Core Competencies examination, consisting of 150 multiple-choice questions. The objective structured clinical evaluation (the "OSCE") is an in-person clinical evaluation that consists of 10 stations.

Finally, the Committee recommended to the Council an increase in the examination fees. Council approved a motion to increase the examination fees with a view to cost neutrality.

Patient Relations Committee

The Patient Relations Committee is a statutory committee under the provisions of the *Regulated Health Professions Act, 1991*. The role of the Committee is to advise Council regarding the College's Patient Relations Program. The Patient Relations Program must include measures for prevention and dealing with abuse of patients. These measures must include:

- Educational requirements for members;
- Guidelines for the conduct of members with their patients;
- Education of College Council and staff; and
- The provision of information to the public.

The Patient Relations Committee also administers the College program on the maintenance and administration of a fund for therapy and counseling for patients who were sexually abused by a registrant.



Fitness to Practise Committee

The Fitness to Practise Committee is a statutory committee. The FTP Committee holds hearings to assess a whether a registrant is incapacitated, after the matter has been referred by the Inquires, Complaints and Reports Committee. If the FTP Committee finds that a registrant is incapacitated, it must make an order directing the Registrar to do any one or more of the following:

- Revoke the registrant's certificate of registration.
- Suspend the registrant's certificate of registration.
- Impose terms, conditions and limitations on the registrant's certificate of registration.

There were no incapacity hearings or other proceedings before the Fitness to Practise Committee in 2022. The Committee did not receive any referrals in 2022 and there were no matters carried over from 2021.





Practice Setting (First Practice Site Only)









Members by Gender
